

# Terms and Conditions WinTree® App version WT/2018/03

# Terms and conditions of use WinTree® App

TSD IT by (hereinafter called TSD) grants you, after agreeing with these Terms and Conditions of use, the right to use the WinTree® App in accordance with these Terms and Conditions.

### Who is allowed to install and use the WinTree® App?

The App is always connected to the database of a company that makes use of WinTree® software. A user who is connected to the company can make use of the App, if that was previously permitted by the administrator within the company. This administrator manages the authorization of the users with the administrator function in their own WinTree® environment.

### How to make safe use of the WinTree® App?

The App gives access to components of the administration of the company to which you are connected. Ensure that the unauthorised persons do not get access to the App. In no case should you provide your credentials such as a login name, password or any other way in which your identity can be confirmed to others. Ensure that your device is secured with at least a personal access code.

Report loss or theft of your mobile device or the suspicion of access by an unauthorised person directly to the administrator of WinTree® within your company. This administrator can block the authorisation via the WinTree® software.

Install your updates for the operating system of your mobile device in time. Updated versions of the operating system contribute to the improvement of safety and functionality.

Respect the (warranty) provisions of the manufacturer of your mobile device and follow the recommendations regarding the safe use of the device.

Make exclusive use of secured connections, for example secured WiFi or a secured mobile data network.

Make use of the updates of the App. In case, you do not use the latest version of the App, it can result into a non-functional App.

### How do you stop the use of the WinTree® App?

If a user is no longer in (active) service at a company that uses WinTree®, then the administrator authorised person within the company has to deactivate the user. This administrator ensures that the App is deleted from the mobile device of the (former) user.

# How is your privacy warranted when using the WinTree® App?

Identification data and with that also linked personal data as available on the mobile device will/can be available to TSD by making use of the App. TSD uses this data exclusively to check the identification for accessing WinTree®. Access to functionalities of the mobile device will exclusively be made to improve the working as well as the use of the App, for example the use of the camera. The App will not access personal data that is saved on the mobile device, for example contact information, unless the user gives explicit permission for this. Not granting the App sufficient privileges or revoking previous privileges may result in unexpected behaviour or malfunction.

Periodically messages can be sent to the user via the App.

TSD has the right to use data in the context of improving the App.
